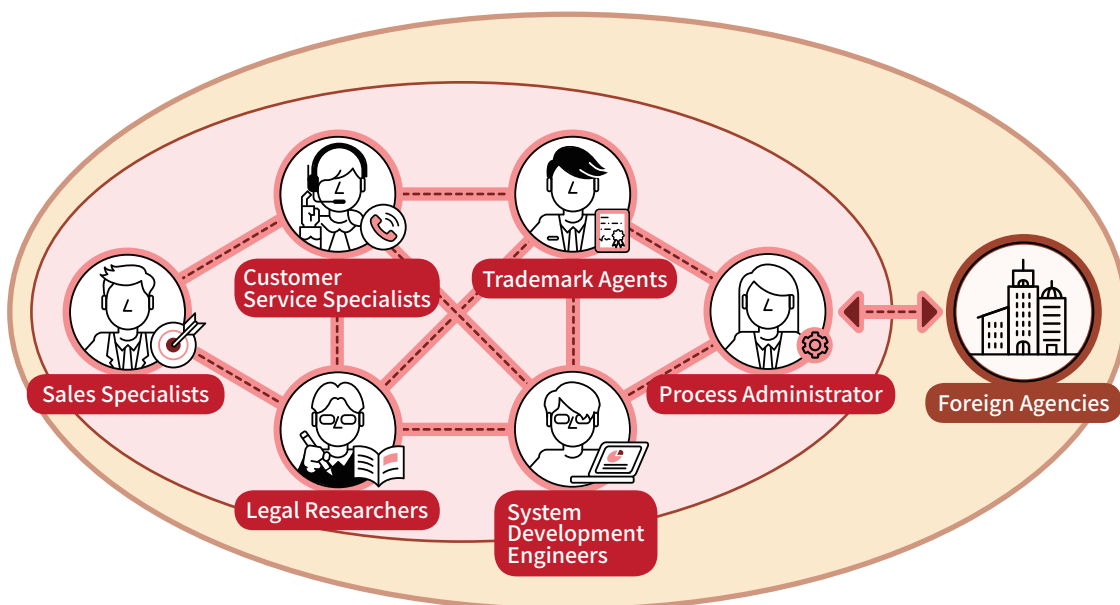
Trademark Infringement Analysis
